FOR LIFT STATIONS: LIBERALLY SATURATE ENTIRE SURFACE AREA OF GREASE CAP AND LET SIT FOR 10 - 20 MINUTES. SPRAY TO MIX WITH HOSE OR HIGH PRESSURE WASHER. AFTER GREASE HAS BEEN DISPERSED, YOU CAN RE-APPLY THIN SPRAY ON SURFACE AREA. REPEAT AS NECESSARY.
